EXTENSION OF LOCAL STATE OF EMERGENCY DECLARATION FOR THE TOWN OF LAKE GEORGE

EXECUTIVE ORDER #2-2020

WHEREAS, the 2019-Novel Coronavirus (COVID-19) pandemic has continued to take a toll on the Country, State and Warren County, and current projections suggest the pandemic spread is unlikely to be resolved in the near future.

WHEREAS, on April 7, 2020, Governor Andrew Cuomo extended the State of Emergency (Executive Order 202) throughout New York State until May 7, 2020; and

WHEREAS, there are over 50 confirmed cases of COVID-19 in Warren County and that number is increasing; and

WHEREAS, the Town of Lake George has a clear governmental interest in protecting the health and safety of the residents, visitors and employees of the Town; and

WHEREAS, pursuant to Section 24 of the Executive Law of the State of New York, the Town Supervisor proclaimed a local State of Emergency on March 17, 2020 for the Town of Lake George, set to expire on April 16, 2020; and

WHEREAS, pursuant to Section 24 of the Executive Law of the State of New York, such proclamation of a local State of Emergency may be extended for additional periods not to exceed thirty (30) days each during the pendency of the local state of emergency;

NOW, THEREFORE, I, DENNIS DICKINSON, Supervisor of the Lake George Town Board, in accordance with the aforementioned and in furtherance of my statutory duties, do hereby order and direct as follows:

IT IS HEREBY ORDERED, that the State of Emergency, as declared and detailed on March 17, 2020 shall be extended for a period of 30 days and remain in effect until May 16, 2020 or until such time as this order may be extended or rescinded as needed.
